As the software is a.net core and very hard to do multithreading (due to dependency/lock). I wonder if I could use CUDA to help my software to edit the video. Does CUDA or OpenCL has their own 4k video processing hardware? A: OpenCL is just a standard API for programs to communicate with GPU's. You have to write the GPU code yourself, but this does not mean your software needs to be multithreaded. The key here is that all modern GPU's are OpenCL capable. You probably already know this, if you're editing 4K video. Your question is very broad, but can be answered in general: it depends on how big your video is, a Laptop GPU might not be powerful enough to edit 4K on the go How much data you need to process: Video compression usually requires more processors, but your GPU can make use of the additional cores Are you going to edit it again after you're done, or only render? Some software will output a file, which you can render multiple times after. How is your software going to communicate?
